All that tract or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 37, Cole Acres, according to plat of property of W. E. McCain by Madison H. Woodward, R. E., May 1946, and recorded in the R.M.C. Office for Greenville County, South Carolina, in PlatBook "P" page 73, and being more particularly described as follows:
