WHEREAS I, George L. Miller, of Greenville County, am well and truly indebted to Crosswell Company

in the full and just sum of Six Hundred, Thirty-Seven and 42/100 - - - - - (\$ 637.42) Dollars, in and by my certain promissory note in writing of even date herewith, due and payable as follows:

Twelve and 50/100 - (\$12.50) Dollars on Saturday, May 14th, 1955 and Twelve and 50/100 - (\$12.50) Dollars on each succeeding Saturday thereafter until the principal debt has been paid in full,

with interest from maturity at the rate of seven (7%) per centum per annum until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid; and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

All that piece, parcel or lot of land, with the improvements thereon, situate, lying and being in or near the City of Greenville, Greenville County, South Carolina, and being more particularly described as Lot 78, Section B, as shown on a plat entitled "A Subdivision for Woodside Mills, Greenville, S. C.", made by Pickell & Pickell, Engineers, Greenville, S. C., January 14, 1950, and recorded in the R.M.C. office for Greenville County in Plat Book W, at pages 111-117, inclusive. According to said plat the within described lot is also known as No. 26 West Main Street and fronts thereon 80 feet; being the same property conveyed to me by Woodside Mills by deed dated May 1, 1950 and recorded in the R. M. C. office for Greenville County in Deed Vol. 410, at page 26.

This is a second and junior mortgage, being junior to the lien of the General Mortgage Company.
