WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. BEGINNING at an iron pin on the southwestern side of East Dorchester Drive at the joint front corner of Lots 85 and 86 and running thence with the line of Lot 86 S. 71-0 W. 219.7 feet to an iron pin; thence N. 23-13 W. 27.2 feet to an iron pin in line of Lot No. 130; thence with the line of Lot No. 130 N. 22-11 E. 56.9 feet to an iron pin in line of Lot No. 84; thence with the line of Lot No. 84 S. 71-0 E. 186.2 feet to an iron pin on East Dorchester Drive; thence with said drive S. 33-0 W. 70 feet to the beginning corner.
