I, Mabel E. White

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Thousand and No/100- - - - -

DOLLARS (\$ 12,000.00), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Western side of Batesview Drive, formerly Bates Street, being known and designated as lot # 16, of Northside Gardens, as shown on plat recorded in Plat Book S at Page 17, and being more particularly described as follows:

"BEGINNING at an iron pin on the Western side of Batesview Drive, joint front corner of lots # 15 and 16, and running thence with the line of lot # 15, S. 57-09 W. 228.3 feet to an iron pin in rear line of lot # 34; thence with rear line of lots # 34 and 33, N. 35-45 W. 80.1 feet to iron pin, rear corner of lot # 17; thence with line of lot # 17, N. 57-09 E. 232.4 feet to iron pin on Batesview Drive; thence with the Western side of Batesview Drive, S. 32-51 E. 80 feet to the point of beginning."
