WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of

Greer, Chick Springs Township, located on the North side of Vandeventer Drive, being all of Lot No. 17 and a small portion from the eastern side of Lots Nos. 4 and 5 on a plat of property made for Dr. J.K. Cornwell, prepared by H.S. Brockman, Surveyor, dated July 3, 1948, and having the following courses and distances: BEGINNING on an iron pin on the northern edge of Vandeventer Drive, joint corner of Lots Nos. 4 and 17, and runs thence N. 7.15 E. 115.6 feet to an iron pin on common line of Lots Nos. 5 and 6; thence S. 76.00 E. 17 feet to an iron pin on line of Lot No. 17; thence N. 15.42 E. 163.3 feet to an iron pin on line of J.C. Cunningham Estate; thence S. 78.54 E. 50 feet to an iron pin; thence with the common line of Lots Nos. 17 and 18 S. 7.31 W. 261.6 feet to a stake on the edge of Vandeventer Drive; thence therewith N.89.12 W. 90 feet to the beginning corner.

Also, all of that other lot of land adjoining the above lot and located on the West side thereof, being a portion of Lot No. 6 of the Evelvn Gentry property, having the following courses and distances: BEGINNING on an iron pin on the dividing line of Lots Nos. 5 and 6 exactly 152.2 feet from iron pin on Pim Street, and runs thence N. 20.17 E. 56.7 feet to an iron pin; thence S. 69.25 E. 12.5 feet to an iron pin on line of above lot; thence S. 15.42 W. 55 feet to an iron pin; thence N. 76 W. 17 feet to the beginning corner.
