NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, , ,

on the west side of the road leading from the Buncombe hoad (State Highway No. 415) from the old Gin site toward Travelers Rest, about one mile southwest from Double Springs Church, containing 5.1 Acres, more or less, and having the following courses and distances, to wit:

Beginning on a stone, old corner, and also corner of the F.W. Andrea home place, and running thence with the Andrea line, S. 73.45 E. 540 feet to a stake in the west edge of said road (another stake back on line at 11 feet); thence with said road, N. 49.30 E. 286.5 feet to a nail and stopper in said road; thence a new line, N. 41.00 W. 27.5 feet to a stake on the western bank of the road; thence continuing with the same course, N. 41.00 W. 256 feet to a stake; thence N. 70.50 W. 249 feet to a stake near the barn; thence S. 83.15 W. 239 feet to a stake; thence S. 18.23 W. 300 feet to the beginning corner.
