Four & one-half per centum (**4½** %) per annum until paid, said principal and interest being payable
at the office of **C. Douglas Wilson & Co.**
in **Greenville, S.C.**

-----, or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of **Forty and 58/100**
----- Dollars (**\$40.58**), commencing on the first day of
July, 1955, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of **June**, 1980.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of **Greenville**
State of South Carolina;

All that certain parcel or lot of land situated on the west
side of Line Street in the City of Greer, Chick Springs Township,
Greenville County, State of South Carolina, designated as Lot
No. 4 of the Property of J. Walter McCarter according to survey
and plat thereof by H.S. Brockman, Surveyor, recorded in Plat
Book T, page 336, R.M.C. Office for Greenville County, and being
particularly shown as the Property of Wilburt E. West according
to survey and plat thereof by H.S. Brockman, Registered Surveyor,
dated May 13, 1955, and having a frontage of 85 feet on Line
Street, a depth of 145.3 feet on the north side, a width of 75.5
feet on the rear line, and a depth of 160.5 feet on the south
side thereof.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances
