NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successsors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 24 on an unrecorded plat of property of Frank Smith, et al, of Mauldin, S. C., dated April 26, 1951, and revised August 14, 1954, having according to said plat the following metes and bounds, to-wit:

"BEGINGING at an iron pin on the southern side of Hyde Circle at the joint front corner of Lots 23 and 24 and running thence S. 39-01 E. 156.1 feet to an iron pin in line of Lot No. 28; thence with the line of Lot No. 28 N. 75-51 E. 10 feet to an iron pin joint rear corner of Lots 24 and 25; thence with the line of Lot No. 23 N. 25-51 E. 136.3 feet to an iron pin on Hyde Circle; thence with said Hyde Circle N. 79-11 W. 127.6 feet to the beginning corner."
