TO ALL WHOM THESE PRESENTS MAY CONCERN:

Evelyn D. Hellams (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **Flora W. Scott**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Three Thousand Five Hundred and No/100 - - - DOLLARS (\$ 3500.00),

with interest thereon from date at the rate of **Five (5%)** per centum per annum, said principal and interest to be repaid: **in monthly installments of \$40.00 each on the 10th day of each month hereafter until paid in full with privilege of anticipating all or any part of the unpaid balance at any time with interest thereon from date at the rate of Five (5%) per cent, per annum, to be computed and paid semi-annually, until paid in full.**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of **Three (\$3.00) Dollars** to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the **Southwestern corner of Wilson Street and 9th Street, near the City of Greenville, being shown as Lot No. 24 of Block C on Plat of Judson Mills No. 2 Village, made by Dalton & Neves, March, 1939, recorded in Plat Book K at Page 2, and described as follows:**

BEGINNING at a stake at the Southwestern corner of Wilson and 9th Streets and running thence with the Western side of 9th St., S. 9-14 E. 78.2 feet to a stake at corner of Lot 23; thence with the line of said lot, S. 80-46 W. 225.4 feet to a stake in line of Lot 1; thence with the line of said lot, N. 9-16 W. 40.2 feet to a stake on Wilson St.; thence with the Southern side of Wilson St., N. 71-14 E. 228.5 feet to the beginning corner.

The above described property is the same conveyed to the Mortgagor by Deed recorded in the R.M.C. Office for Greenville County in Deed Book 482, at page 49.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
