WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

DOLLARS (\$ 5900.00), with interest thereon from date at the rate of Six (6%)
per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the South side of the Old National Highway, in the town of Taylors, and being shown and designated as Lots Nos. 13, 13A, 14 and 14A of a subdivision of the property of C. E. Shockley as per plat made by T. T. Snyder and recorded in the RMC Office for Greenville County in Plat Book F at Page 89, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of the Old National Highway, at the joint front corner of Lots Nos. 12 and 13, and running thence with line of Lot 12 due South 280 feet to point on the North side of the right-of-way of the P. & N. Railway; thence along the P. & N. Railway right-of-way in a southwesterly direction 107.7 feet to pin at corner of Lot 15A; thence with the line of Lots 15A and 15 due North 320 feet to pin on Old National Highway; thence with the Old National due East 100 feet to pin, the point of beginning.
