(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100 - - - -

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Gantt Township, being known and designated as Lot No. 3 on Plat of property of Albert Taylor recorded in the R.M.C. Office for Greenville County in Plat Book II, at page 129, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Springbrook Drive, at the joint front corner of Lots Nos. 2 and 3, and running thence with the line of Lot No. 2, S. 0-38 E. 140 feet to an iron pin in line of Lot No. 4; thence with the line of Lot No. 4, S. 86-35 E. 69.5 feet to an iron pin; thence N. 0-38 W. 140 feet to an iron pin on the Southern side of Springbrook Drive; thence with said Drive, N. 86-35 W. 69.5 feet to the beginning corner.

ALSO, all that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, in Gantt Township, being known and designated as Lot No. 6 on Plat of property of Albert Taylor recorded in the R.M.C. Office for Greenville County in Plat Book HH, at page 173, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Springbrook Drive, joint front corner of Lots Nos. 5 and 6, and running thence with the line of Lot No. 5, S. 0-38 E. 104.5 feet to an iron pin; thence S. 86-35 E. 104.5 feet to an iron pin in line of Lot No. 7; thence with the line of Lot No. 7, N. 0-38 W. 104.5 feet to an iron pin on the Southern side of Springbrook Drive; thence with said Drive, N. 86-35 W. 104.5 feet to the beginning corner.

Lot No. 3 above referred to is a portion of property conveyed to the Mortgagor by Deeds recorded in the R.M.C. Office for Greenville County in Deed Book 518, page 254 and Deed Book 519, page 60. Lot No. 6 above referred to is a portion of property conveyed to the Mortgagor by Deed recorded in the R.M.C. Office for Greenville County in Deed Book 509, at page 498. Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
