Cely, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 119, Section II, Lake Forest Subdivision, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "EE", page 71, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Hermitage Road, joint front corner Lots 118 and 119, and running thence S. 86-31 E. 225 feet to a point where the joint line of Lots 118 and 119 intersect the high water line of Lake Fairfield; thence along the high water line of Lake Fairfield, the traverse line being S. 34-27 W. 145.8 feet to a point where the joint line of Lots 119 and 120 intersects the high water line of Lake Fairfield; thence N. 86-31 W. 157 feet to an iron pin on the Easterly side of Hermitage Road; thence along the Easterly side of Hermitage Road; thence along the Easterly side of Hermitage Road N. 3-29 E. 125 feet to an iron pin, the point of beginning.
