"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the Northern side of a branch, and being described as follows:

"BEGINNING at a stake in branch on the Southern side of New Road, thence along Southern side of said road, S. 66-05 E. 235 feet to a bend; thence S. 44-28 E. 200 feet to bend; thence S. 27-50 E. 300 feet to a bend; thence S. 35-04 E. 300 feet to bend; thence S. 22-15 E. 200 feet to bend; thence S. 31-03 E. 200 feet to bend; thence S. 47-38 E. 200 feet to bend; thence S. 64-05 E. 200 feet to bend; thence S. 37-24 E. 35 feet to stake on side of road; thence S. 29 W. 331 feet to iron pin; thence N. 85-45 W. 515 feet to iron pin in branch; thence down branch 345 feet, more or less, to stake; thence down branch 1023 feet, more or less, to stake: thence down branch 310 feet, more or less, to the beginning, containing 16.40 acres, more or less."
