Fidelity Federal Savings And Loan Association, a corporation organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Nine Thousand and No/100 Dollars (\$ 9,000.00), with interest from date at the rate of four and one-half per centum (4 1/2 %) per annum until paid, said principal and interest being payable at the office of Fidelity Federal Savings And Loan Association in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty and 03/100 Dollars (\$ 50.03), commencing on the first day of September, 1955, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of August, 1980.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, Gantt Township State of South Carolina; and being known and designated as Lot No. 49 of Pecan Terrace according to a plat thereof prepared by Piedmont Engineering Service dated March 27, 1953 and recorded in the R. M. C. Office for Greenville County in Plat Book "GG", at Page 9 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Augusta Road, joint front corner of Lots Nos. 48 and 49 and running thence along the joint side line of said lots S. 69-0 E. 140 feet to an iron pin, joint rear corner of said lots; thence S. 1-12 E. 79.4 feet to an iron pin, joint rear corner of Lots Nos. 49 and 50; thence along the joint side line of said lots N. 69-30 W. 170 feet to an iron pin on the eastern side of Augusta Road; joint front corner of Lots Nos. 49 and 50; thence along the eastern side of said Road N. 21-01 E. 75 feet to the beginning corner.

The above is the same property conveyed to the mortgagor by Frank Ulmer Lumber Company by its deed of even date and recorded herewith.
