To All Whom These Presents May Concern

TROY F. GRIFFIN

hereinafter spoken of as the Mortgagor send greeting.

Whereas TROY F. GRIFFIN

is justly indebted to C. Douglas Wilson & Co., a corporation organized and existing under the laws of the State of South Carolina, hereinafter spoken of as the Mortgagee, in the sum of Thirteen Thousand and No/100-----Dollars

(\$ 13,000.00), lawful money of the United States which shall be legal tender in payment of all debts and dues, public and private, at the time of payment, secured to be paid by that one certain note or obligation, bearing even date herewith, conditioned for payment at the principal office of the said C. Douglas Wilson & Co., in the City of Greenville, S. C., or at such other place either within or without the State of South Carolina, as the owner of this obligation may from time to time designate, of the sum of Thirteen Thousand and No/100-----Dollars (\$ 13,000.00)

with interest thereon from September 1, 1955 at the rate of Five per centum per annum, to be paid on the 1st day of October 1955, and on the 1st day of each month thereafter the sum of \$ 85.80 to be applied on the interest and principal of said note, said payments to continue up to and including the 1st day of August, 1975, and the balance of said principal sum to be due and payable on the 1st day of September, 1975; the aforesaid monthly payments of \$ 85.80 each are to be applied first to interest at the rate of Five per centum per annum on the principal sum of \$ 13,000 or so much thereof as shall from time to time remain unpaid and the balance of each monthly payment shall be applied on account of principal. Said principal and interest to be paid at the par of exchange and net to the obligee, it being thereby expressly agreed that the whole of the said principal sum shall become due after default in the payment of interest, taxes, assessments, water rate or insurance, as hereinafter provided.

Now, Know All Men, that the said Mortgagor in consideration of the said debt and sum of money mentioned in the condition of the said note and for the better securing the payment of the said sum of money mentioned in the condition of the said note with the interest thereon, and also for and in consideration of the sum of One Dollar in hand paid by the said Mortgagee, the receipt whereof is hereby acknowledged, has granted, bargained, sold, conveyed and released and by these presents does grant, bargain, sell, convey and release unto the said Mortgagee and to its successors, legal representatives and assigns, for even, all that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being on the Southeast side of Wade Hampton Boulevard (also known as U. S. Highway No. 29) near Greenville, in Greenville County, South Carolina, being shown as Lot No. 1 on Plat of Property of Irene B. Ducker, made by Dalton & Neves, Engineers, October, 1954, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "HH", page 132, said lot fronting 90 feet along the Southeast side of Wade Hampton Boulevard, running back to a depth of 327.2 feet on the Northeast side, to a depth of 328.7 feet on the Southwest side, and being 75 feet across the rear.

This is the same property conveyed to me by deed of Irene B. Ducker, to be recorded herewith.
