SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Seven Thousand, Five Hundred and No/100 - - - - - -

(\$ 7.500.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this (\$ 7.500.00 loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel of lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 28 and a small portion of Lot No. 26, Section B, of a subdivision known as Pinehurst according to a plat thereof recorded in the R. M. C. office for Greenville County in Plat Book S, at page 77, and being also known and designated as Lot No. 4 of the property of C. Spencer Willingham according to a plat thereof prepared by J. Mac Richardson, Surveyor, January, 1955 and recorded in the R. M. C. office for Greenville County in Plat Book II, at page 35, and having, according to the last mentioned plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northeastern side of Hale Drive, the joint front corner of Lots Nos. 28 and 30, Section B, of the Pinehurst Subdivision, which pin is 660 feet along Hale Drive from the intersection of Hale Drive with Hazel Street, and running thence N. 62-23 E. 136.5 feet to an iron pin; thence along the rear lines of Lots Nos. 27 and 25, Section B, of the Pinehurst Subdivision, N. 27-37 W. 75 feet to an iron pin; thence on a line through Lot No. 26, Section B, of the Pinehurst Subdivision, S. 62-23 W. 137.6 feet to an iron pin on the northeastern side of Hale Drive; thence along the northeastern side of Hale Drive, S. 28-27 E. 75 feet to the beginning corner; being the same conveyed to us by C. S. Willingham by deed of even date herewith, not yet recorded."
