WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs,

Township, near the corporate limits of Greer and west therefrom, lying

on the South side of Golf Street, having the following courses and

distances: BEGINNING at a point on line of J.P. Stevens & Co. property-

which point is N. 52.50 W. 18 feet from concrete monument, and runs

thence with line of that property N. 52.50 W. 110 feet to an iron pin

on said line, old corner of original Clayton lot; thence with the old

Clayton line S. 42.18 W. 167 feet to an iron pin on old line; thence

with the said line S. 34.15 E. 99.5 feet to an iron pin on said line;

thence N. 45.45 E. 200 feet (new line) to the beginning corner, and
