All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Butler Township, Greenville County, State of South Carolina, being known and designated as Lot No. 4 of a subdivision known as North Gardens, Section No. 2, and recorded in Plat Book "EE" at page 103, and having the following metes and bounds:
