organized and existing under the laws of South Carolina, a corporation, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of TEN THOUSAND FOUR HUNDRED AND NO/100 - - - - - Dollars (\$ 10,400.00 ), with interest from date at the rate of four & one-half per centum ( 4½ %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of - - - - - Fifty-Seven and 81/100 - - - - - Dollars (\$ 57.81 ), commencing on the first day of November, 1955, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of October, 19 80.

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 184 on Plat of Paramount Park, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "W", at page 57; said lot having a frontage of 70 feet on the Southeasterly side of Mayo Drive, a depth of 150 feet on the Southwest, a depth of 150 feet on the northeast and 70 feet across the rear.
