In consideration of the sum of One (\$1.00) Dollar, the receipt and sufficiency of which is hereby acknowledged, THE MUTUAL LIFE INSURANCE COMPANY OF NEW YORK, a New York corporation, the owner and holder of a certain Note and Mortgage in the original amount of \$18,000.00, executed to C. DOUGLAS WILSON & CO. by NORMAN R. SEIBERT, said Mortgage being recorded in the R. M. C. Office for Greenville County, South Carolina, in Book of Mortgages 566, at Page 441, and assigned to said THE MUTUAL LIFE INSURANCE COMPANY OF NEW YORK by Assignment recorded in said Office in Book 566, at Page 444, does hereby release, relinquish, and forever discharge the following described real property:

ALL that piece, parcel or lot of land located on Crestwood Drive, near the City of Greenville, South Carolina, and being more fully described as follows:

BEGINNING at an iron pin on the Northwesterly side of Crestwood Drive, said point being 202.3 feet from the Northerly side of Hillandale Circle as measured along the Northwesterly side of Crestwood Drive; running thence North 59 degrees West, 115.8 feet to an iron pin; thence North 63 degrees, 50 minutes West, 44.9 feet to an iron pin on the Southerly line of the Ellis property; thence South 86 degrees, 45 minutes East along the Ellis property, 185.1 feet to the Northwesterly side of Crestwood Drive; thence South 33 degrees, 42 minutes West along the Northwesterly side of Crestwood Drive 79.7 feet to the point of beginning.

Provided, however, that this release shall in no wise affect the indebtedness described in said Note and Mortgage, or affect the lien of said indebtedness on the part of the premises described in said Mortgage not hereby released.
