Bowen, his heirs and assigns forever, all that certain piece, parcel, or lot of land situate, lying and being on the north side of North Haven Drive, near the city of Greenville, Greenville County, South Carolina, shown as Lot No. 24 on plat of Buncombe Park made by W. J. Riddle, surveyor, May, 1944, recorded in the R. M. C. office for Greenville County in plat book M at page 12, and having, according to said plat, the following metes and bounds, to-wit:
