Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina;

ALL that certain lot of land with the buildings and improvements thereon located in the State of South Carolina, County of Greenville, in Chick Springs Township, in the City of Greer, on the Southwest side of Carolina Avenue, and being known and designated as Lot No. 22 on plat of Development No. 2, Victor Monaghan, Division of J. P. Stevens & Co. Inc., Greer Plant, prepared by Dalton & Neves, Engineers, April, 1947, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "P", page 119; said lot fronting 105 feet along the Southwest side of Carolina Avenue, running back to a depth of 170 feet on the Southeast side, to a depth of 170 feet on the Northwest side, and being 105 feet across the rear.
