All that certain piece, parcel or tract of land, together with the buildings and improvements thereon situate, lying and being in Butler Township, Greenville County, State of South Carolina, being shown as all of Lot Eight, on Plat of Property of Lucy L. Hindman, prepared by W. J. Riddle, in October, 1939 (revised June 4, 1942), which plat is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "Y" at Pages 50-51 (also at pages 18-19), reference to which plat is expressly craved for a more detailed description.

The above parcel is part of the same conveyed to the mortgagor by Deed of C. C. Hindman, Jr., et al, dated October 6, 1950, recorded in Deed Book 421, at Page 51.
