On the East side of the North Parker Road and on the West side of Davidson Road, near the City of Greenville, in Paris Mountain Township, designated as Lots Nos. 3 and 5 on Plat of property of L. A. Mills, made by Piedmont Engineering Service, October 13, 1950, recorded in the R.M.C. Office for Greenville County, S.
