), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: in monthly installments of \$100.00 each on the 10th day of each month hereafter until paid in full, with interest thereon from date at the rate of six (6%) per cent per annum to be computed and paid semi-annually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern corner of Woodlawn Avenue and Landall Street, in the City of Greenville, being a portion of Lot 52 as shown on a plat of Don Wood, recorded in Plat Book A at Page 463, in the R. M. C. Office for Greenville County, and having the following metes and bounds, to-wit: .

"BEGINNING at a stake at the northwestern corner of Woodlawn Avenue and Landell Street and running thence with the western side of Woodlawn Avenue N. 16-05 W. 110 feet to a stake at corner of other property of the grantee; thence with the line of said property S. 74-26 W. 58.5 feet more or less to stake in line of Lot 53; thence with the line of said lot S. 15-20 E. 110 feet to a stake on Landall Street; thence with the northern side of said street N. 74-73 E. 59.8 feet to the beginning corner."

Being the same property convey to the mortgagor by Fred M. Thompson and J. P. Thompson as Trustees by deed recorded herewith.
