NOW, THEREFORE, the mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to him in hand paid by the mortgagee at and before the sealing and delivery of this mortgage, the receipt of which is hereby acknowledged, by these presents hereby bargains, sells, grants and releases unto the said SHENANDOAH LIFE INSURANCE COMPANY:

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, state of South Carolina, being the southwest portion of lot No. 4 on plat of property of Eliza D. Ware, shown on plat recorded in the R. M. C. Office for Greenville County in plat book M page 27, and according to a recent survey by T. C. Adams, having the following metes and bounds, to-wit:
