THIS MORTGAGE, made the 11th day of February, 1956, between  
George Fischer and Antoinette T. Fischer

of the County of Greenville, State of South Carolina, hereinafter called Mortgagor, and  
THE PRUDENTIAL INSURANCE COMPANY OF AMERICA, a New Jersey corporation, having its principal office in  
Newark, New Jersey, hereinafter called Mortgagee,

WHEREAS, Mortgagor is indebted to Mortgagee for money loaned, to secure the payment of which Mortgagor has exe-  
cuted and delivered to Mortgagee a note of even date herewith, in the principal sum of

Fifteen Thousand and No/100ths - - - - - Dollars (\$ 15,000.00 ),

payment of said indebtedness as in said note provided, (2) payment of all other moneys secured hereby and (3) the performance  
of all the covenants, conditions, stipulations and agreements herein contained, does by these presents grant, bargain, sell and  
release to Mortgagee, its successors and assigns, the following described real estate situated in the township  
of Chick Springs Greenville County, South Carolina, designated as  
Lot No. 5 on a plat of Forest View, prepared by T. C. Adams, dated  
February, 1955, and recorded in the R. M. C. Office for Greenville  
County in Plat Book II at page 105, and having according thereto the  
following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Galphin Drive  
at the joint front corner of Lots Nos. 5 and 6, and running thence  
along Galphin Drive N. 79-44 E. 100 feet to an iron pin; thence along  
the line of Lot No. 4 S. 10-16 E. 183.5 feet to an iron pin; thence  
along the line of Lot No. 8 S. 84-29 W. 100.3 feet to an iron pin;  
thence along the line of Lot No. 6 N. 10-16 W. 175 feet to the point  
of beginning.
