"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as a portion of Lots No. 136 and No. 137, as shown on a plat of the property of Isaqueena Park, recorded in the R. M. C. Office for Greenville County in Plat Book P at Pages 130 and 131, and having according to a more recent survey prepared by J. C. Hill, the following metes and bounds, to-wit:
