MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

H. L. Feden

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Easterby Motor Company, a Corporation (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Sixty-five Thousand and No/100 - -

one-half (5½%) DOLLARS (\$ 65,000.00),
with interest thereon from date at the rate of five & / per centum per annum, said principal and interest to be repaid: in monthly installments of \$1241.60 each on the first day of each month hereafter, beginning on May 1, 1956, to be applied first to interest and then to principal until paid in full, with interest thereon from date at the rate of five & one-half (5½%) per cent. per annum, to be computed and paid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Mayberry Street in the City of Greenville and according to a survey made by Dalton & Neves in July, 1940, is described as follows:

"BEGINNING at a stake on the eastern side of Mayberry Street at the corner of property now or formerly owned by Textile Broadcasting Company and running thence with the line of said property N. 46-50 E. 405 feet to a stake on the southwestern side of a street; thence with the southwestern side of said street S. 47-00 E. 350 feet to a stake at the intersection of a 50 feet street; thence N. 32-30 E. 195 feet to a stake on the right-of-way of C. & W. C. Railway; thence with said right-of-way N. 47 W. 468.5 feet to a stake; thence continuing with said right-of-way N. 46-00 W. 127.5 feet to a stake; thence continuing with said right-of-way N. 45-10 W. 150 feet to a stake at the intersection of the right-of-way of the Southern Railway; thence with the right-of-way of Southern Railway S. 51 W. 70.8 feet to a stake on Mayberry Street; thence with the eastern side of Mayberry Street S. 23-15 E. 22 feet to a stake; thence continuing with said Mayberry Street S. 9-50 W. 567 feet to a stake; thence with the curve of Mayberry Street, the chord of which is S. 5-45 E. 100 feet to the beginning corner." Being the same property conveyed to the mortgagor by deed recorded in Deed Book 315 at Page 352.

This description includes within its boundaries the street conveyed to the City of Greenville by the mortgagor by deed recorded in Deed Book 409 at Page 311, and of course said street is not included in this mortgage.

ALSO: All that tract of land in Gantt Township, Greenville County, State of South Carolina, on the southern side of White Horse Road, being the major portion of Tract No. 3 as shown on a plat of property of T. G. Batson made by R. E. Dalton containing approximately 13 acres and described as follows: BEGINNING in the center of White Horse Road at corner of Lots 3 and 4 on the T. D. Batson tract of land, which is 489.5 feet N. 76-50 W. from lands now or formerly of McWhite, and running thence along the center of said White Horse Road N. 76-50 W. 367 feet to corner of Tracts 2 and 3; thence along the joint lines of said tracts S. 4-30 E. 1812.5 feet to an iron pin on lands now or formerly of John McWhite; thence along McWhite lands N. 55-12 E. 467 feet to iron pin; thence along line of Lots 3 and 4 N. 4-30 E. 1475 feet to beginning. LESS, HOWEVER, a lot fronting 80 feet on the southern side of White Horse Road with a depth of 200 feet located at the northwestern corner of this tract which is not owned by the mortgagor, and being the same property conveyed to
