

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. 167 of a Subdivision known as Oakcrest, Section 2, according to a plat thereof prepared by C. C. Jones, Associates, January 1955, and recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Pages 130 and 131, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southeastern side of Maryland Avenue at the joint front corner of Lots Nos. 166 and 167, and running thence along the joint line of said lots, S. 73-31 E. 150 feet to an iron pin; thence S. 16-29 W. 70 feet to an iron pin at the rear corner of Lot No. 168; thence along the line of that lot, N. 73-31 W. 150 feet to an iron pin on the southeastern side of Maryland Avenue; thence along the southeastern side of Maryland Avenue, N. 16-29 E. 70 feet to the beginning corner."
