Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

All that certain parcel or lot of land situated on the south side of Lancaster Avenue and the east side of Brockman Street in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, being the greater portion of Lot No. 130 of the W.H. Brockman Estate, plat recorded in Plat Book H, page 132, R.M.C. Office for Greenville County, and being particularly designated and shown as the Property of Robert E. Gaither according to survey and plat thereof by H.S. Brockman, Registered Surveyor, dated April 2, 1956, and recorded in Plat Book FF, page 399, R.M.C. Office for Greenville County, and having a uniform width of 70 feet and a uniform depth of 135 feet. This property is further identified as No. 109 Lancaster Avenue.
