NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Sixth Avenue, Poe Mill, in Greenville Township, and being shown as Lot 213, Section 1, on Plat of F. W. Poe Manufacturing Company recorded in Plat Book "Y" at Pages 26-31, and having according to said plat the following metes and bounds:

"BEGINNING at an iron pin on the northeastern side of Sixth Avenue joint front corner of Lots 213 and 212 and running thence along the line of Lot 212 N. 42-38 E. 71.7 feet to an iron pin on Hammett Street; thence with the southwestern side of said Hammett Street S. 68-20 E. 60 feet to an iron pin corner of Lot 243; thence with the line of Lot 243 S. 18-05 W. 49 feet to pin corner of Lot 214; thence with the line of Lot 214 S. 44-34 W. 56.1 feet to pin on Sixth Avenue; thence with the northeastern side of Sixth Avenue N. 41-27 W. 75 feet to the point of beginning."
