All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in **Bates Township, Greenville County, State of South Carolina, being known and designated as Lot No. 94 as shown on a plat of Sunny Acres Subdivision, prepared by J.C.
