NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southwesterly side of the Old Finley Bridge Road in Greenville County, State of South Carolina, containing 3 acres, more or less, and having, according to a plat dated May 14, 1956, prepared by J. C. Hill entitled "Property of Lois Brown Roache," recorded in the R.M.C. Office for Greenville County in Plat Book JJ at page 199 the following metes and bounds:

BEGINNING at a point in the center of the Old Finley Bridge Road, which point is located 405 feet, more or less, in a Northwesterly direction from the intersection of the Keeler Bridge Road and the Old Finley Bridge Road, and running thence along the center of the Old Finley Bridge Road N. 53-50 W. 154 feet to a point; thence continuing along the center of the Old Finley Bridge Road, N. 41-00 W. 254 feet to a point; thence still continuing along the center of the Old Finley Bridge Road, N. 30-00 W. 100 feet to a point; thence S. 38-30 W. 7.2 feet to an iron pin; thence S. 38-30 W. 396.8 feet to an iron pin; thence S. 71-00 E. 496 feet to an iron pin; thence N. 49-30 E. 156 feet to an iron pin; thence N. 49-30 E. 13 feet to the point of beginning.
