NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lots Nos. 1 and 2 of Block O of a subdivision known as Highland according to a plat thereof prepared by Dalton & Neves, Engineers, July, 1940 and recorded in the R. M. C. office for Greenville County in Plat Book K, at pages 50 and 51, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southwestern side of Florida Avenue, joint front corner of Lots Nos. 2 and 3, and running thence along the southwestern side of Florida Avenue, N. 22-10 W. 100 feet to an iron pin; thence following the curvature of Florida Avenue as it converges with Oconee Street, the chord of which is 21.7 feet to an iron pin on the southeastern side of Oconee Street; thence along the southeastern side of Oconee Street; thence along the southeastern side of Oconee Street, S. 71-00 W. 185 feet to an iron pin at the rear corner of Lot Nos. 27; thence along the rear line of Lots Nos. 27 and 26, S. 22-10 E. 126 feet to an iron pin at the rear corner of Lot Nos. 3; thence along the line of that lot, N. 67-50 E. 199.6 feet to an iron pin on the southwestern side of Florida Avenue, the beginning corner; being the same conveyed to mortgagor corporation by Daniel E. Matthews and Mildred S. Matthews by deed of even date herewith, not yet recorded."
