C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to the said mortgagor. in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CTTIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, about 2 miles North of Travelers Rest, S. C., on the N/S of State Road 23-131, adjoined on the South by said read, on the West by the Nerman Bates Estate, on the North by Clifton Ables and Lula Hudson Stone on the East, and having, according to a survey made by Dean C. Edens, licensed surveyer, April 14, 1956, the following metes and bounds, courses and distances, to-wit:
