

All that certain piece, parcel or tract of land lying and being in Austin Township, Greenville County, State of South Carolinam being known and designated as tract No. 20 on a plat of property of Marsmen, Inc., made by Dalton & Neves, August 1946, recorded in the R. M. C. Office for Greenville County in Plat Book "S", page 75, and having according to said plat, the following metes and bounds, to-wit:
