a corporation chartered under the laws of the State of South Carolina, in and by its certain promissory note in writing, of even date with these presents, is well and truly indebted to Thornwell Orphanage of Clinton, South Carolina in the full and just sum of Fifty-Seven Thousand Five Hundred & NO/100

(\$57,500.00), to be paid in monthly payments of \$609.91 each, beginning one month from the date hereof and continuing each consecutive month thereafter until paid in full; each payment to be applied first to interest at 5% per annum and the balance to principal until paid in full. Term of loan: 10 years. Privilege is hereby reserved to pay all or any part of the balance on any interest paying date.

, with interest thereon from date

at the rate of 5 per centum per annum, to be computed and paid monthly along with principal

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All those certain pieces, parcels or lots of land, together with the improvements situate thereon, located on the West side of Jones Avenue in the City and County of Greenville, State of South Carolina, and being known and designated as lots nos. 54, 55 and 56 as shown on a plat recorded in the R.M.C. Office for Greenville County in Plat Book "E", at page 137, and having, in the aggregate, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Augusta Road, joint corner of lots nos. 56 and 57, and running thence with Augusta Road, S. 46-21 E. 254.7 feet to an iron pipe at the corner of lot no. 54, at intersection of Jones Avenue and Augusta Road; thence with Jones Avenue, N. 0-50 W. 272.6 feet to an iron pin; thence N. 46-21 W. 61.2 feet to an iron pin, joint corner of lots nos. 56 and 57; thence with the common line of lots nos. 56 and 57, S. 43-39 W. 200 feet to the beginning corner.
