"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northern side of Primrose Lane, and being known and designated as Lot 64 of Northside Gardens as shown on plat recorded in Plat Book S at page 17, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Primrose Lane at the joint front corner of Lots 63 and 64, and running thence with the line of Lot 63, N. 9-15 W. 200 feet to an iron pin in line of property formerly owned by J. M. Gilfillin; thence with the line of the Gilfillin property, N. 80-45 E. 90 feet to an iron pin, corner of Lot 65; thence along the line of lot 65, S. 9-15 E. 200 feet to an iron pin on the North side of Primrose Lane; thence along the North side of Primrose Lane, S. 80-45 W. 90 feet to the point of beginning.
