"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lot # 22 on plat of Farr Estates, recorded in Plat Book M at Page 19, and described as follows:
