All that piece, parcel or lot of land situate, lying and being in the Town of Greer, Greenville County, State of South Carolina, being known and designated as Lot No. 95, as shown on a plat of the W. H. Brockman Estate, prepared by Dalton & Neves, dated June, 1926, recorded in the R.M.C. Office for Greenville County in Plat Book H at page 132, and having, according to a more recent plat prepared by Piedmont Engineering Service, dated June 25, 1956, entitled "Property of B. L. Harvey, Jr. and Toya A. Harvey" the following metes and bounds:
