WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, located about two (2) miles north from the City of Greer and on the northeastern side of Memorial Drive Extention, also known as the Greer-Oneal Highway, being all of Lot No. 8 on Plat No. 2 of the L.W. Jones Estate property made by H.S. Brockman, Surveyor, dated May 24, 1951, recorded in the R.M.C. Office for Greenville County, and having the following courses and distances:

BEGINNING at a point in the said Memorial Drive Extention or Greer-Oneal Highway (iron pin on northeast bank of said highway), joint corner of Lots Nos. 7 and 8 on said plat, and runs thence with the common lines of these lots N. 31.52 E. 258.1 feet to a stake on line of Lot No. 9; thence with line of Lot No. 9 N. 38.48 W. 125 feet to a stake, joint rear corner of Lots Nos. 8 and 10; thence with the line of these lots S. 47.34 W. 301.6 feet to a point in said highway (iron pin on northeast bank of highway); thence adong and with said highway S. 53 E. 100 feet and S. 58 E. 100 feet to the beginning corner.
