That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, School District 95, about one mile East of Piedmont, on waters of Grove Creek, being shown and described as containing 43.57 acres, more or less, according to a plat of property prepared by W. J. Riddle, Surveyor, March 14, 1945, and having the following courses and distances, to wit:-

BEGINNING at a stake in center of Grove Creek Road, corner of (now or formerly) property of Nettie Hill, and running thence with the Hill line, S 35-00 W 350 feet to a stake; thence continuing with the line of Hill, S 47-00 W 1687 feet to a stake on line of Mrs. Webb; thence with the line of Webb, N 49-45 W 767 feet to an iron pin, corner of Wade property (formerly Nesbitt); thence with the old line of Nesbitt, N 34-15 E 2035 feet to an iron pin in center of Old Grove Creek Road and near the new location of said road; thence with center of said old road N 65-25 W 250.8 feet to a stake in center of said old road; thence N 11-05 E 179.6 feet to a stake in center of the New Grove Creek Road; thence with the center of said new road, S 45-30 E 528 feet to a stake; thence continuing with the center of said road, S 45-30 E 931 feet to the point of beginning.
