"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the north-western side of Toler Road, being shown as Lot No. 19 on plat of Meadowbrook Farms, recorded in the R. M. C. Office for Greenville County in Plat Book M at Page 22, and described as follows:

"BEGINNING at a stake on the northwestern side of Toler Road 126.2 feet southwest from Sullivan Road at corner of Lot No. 20, and running thence with the line of said lot N. 32-15 W. 277.5 feet to a stake; thence S. 57-45 W. 62 feet to a stake at corner of Lot No. 18; thence with line of said lot S. 32-15 E. 277.5 feet to a stake on Toler Road; thence with the northwestern side of said road N. 57-45 E. 62 feet to the beginning corner."
