NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as the front portion of Lot 6 of a Subdivision known as High View Acres, a plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book 0 at page 123, and being more particularly described by metes and bounds, as follows:

BEGINNING at an iron pin on the East side of Courtland Drive at the rear corner of Lot 5 and running thence with line of Lots 5 and 4, N. 87- E. 237.5 feet to an iron pin; thence N. 8.10 E. 214.7 feet to an iron pin; thence N. 84-30 W. 245.2 feet to an iron pin on Courtland Drive; thence with the East side of Courtland Drive, S. 5-30 W. 260 feet to point of beginning.
