Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Fifty-Nine and 49/100----- Dollars (\$ 59.49 ), commencing on the first day of December, 19 56, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of November, 19 81.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 22, Section 1, Plat of Oak-Crest, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", pages 110-111, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Templewood Drive on the curve of the intersection of Templewood Drive and Brownwood Drive, and running thence along the curve of said intersection, the chord of which is N. 74-58 W. 35.4 feet to an iron pin on Brownwood Drive; thence along Brownwood Drive N. 29-58 W. 125 feet to an iron pin; thence along the line of Lot No. 15 N. 60-02 E. 80 feet to an iron pin; thence along the line of Lot No. 21 S. 29-58 E. 150 feet to an iron pin on the Northerly side of Templewood Drive; thence along the Northerly side of Templewood Drive S. 60-02 W. 55 feet to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
