Fifty-One and 99/100- ----- Dollars (\$ 51.99 ),  
commencing on the first day of December, 19 56, and on the first day of each month there-  
after until the principal and interest are fully paid, except that the final payment of principal and interest,  
if not sooner paid, shall be due and payable on the first day of November, 19 81.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,  
State of South Carolina:

All that piece, parcel or lot of land, with the buildings and improvements thereon,  
situate, lying and being near the City of Greenville, in the County of Greenville,  
State of South Carolina, being known and designated as part of Lot No. 15, Plat of  
Property of Eliza D. Ware, which plat is recorded in the R.M.C. Office for Greenville  
County, South Carolina, in Plat Book "M", page 27, and having, according to said plat  
and according to a more recent plat of the Property of Don C. Litman, made by  
Piedmont Engineering Service, October, 1956, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Viewpoint Drive, joint front corner  
Lots 15 and 16, and running thence S. 50-50 E. 265 feet to an iron pin; thence along  
the line of Lot No. 14, S. 55-02 W. 60 feet to an iron pin; thence N. 64-11 W. 227.6  
feet to an iron pin on Viewpoint Drive; thence along the curve of Viewpoint Drive,  
the chord of which is N. 2-0 E. 15 feet and N. 28-45 E. 100 feet to the point of  
beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-  
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be  
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter  
attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and  
assigns forever.
