**Sixty Four and 50/100** Dollars (\$ 64.50 ), commencing on the first day of **January**, 1957, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **December**, 19 81

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of **Greenville, in the City of Greenville**, State of South Carolina; known as a portion of lot no. 152 according to plat of **Isaqueena Park made by Pickell & Pickell dated June 3, 1947 and recorded in the R.M.C. Office for Greenville County in Plat Book P at Pages 130 and 131, and having, according to said plat, the following metes and bounds, to-wit:**

Beginning at an iron pin on the northwestern side of Kirkwood Lane at the joint front corner of lots nos. 151 and 152, which iron pin is situate 180.4 feet northeast of the intersection of Kirkwood Lane and Dupont Drive and running thence along the line of lot no. 151, N 45-51 W, 170 feet to an iron pin; thence N 52-54 E, 65.8 feet to an iron pin in the line of lot no. 153; thence along the line of lot no. 153, S 45-51 E, 160 feet to an iron pin on the northwestern side of Kirkwood Lane; thence with said Lane, S 44-09 W, 65 feet to the point of beginning.
