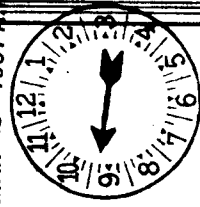

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said The Pelzer-Williamston Bank, its successors and assigns forever;

All that piece, parcel or lot of land in Dunklin Township, Greenville County, State of South Carolina, about twenty (20) miles, south of the City of Greenville, near and on the right of Highway leading from Pelzer to Honea Path, South Carolina, adjoining lands now owned by Dordozie Chapman, Anna Chapman, Andy Owens and Eugene King, containing One (1) acre, more or less, being the Home Place of our Mother, Tina Johnson, and occupied by her as a home for a period of Sixty (60) years, and being the same parcel or lot of land conveyed to us by Carneliu Johnson, Milton Johnson, Titus Johnson, Timothy and E.D. Johnson by their deed.
