in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

C. E. Robinson, as Trustee under B. M. McGee Will, his successors and assigns forever:

All that piece, parcel or tract of land situate, lying and being in Greenville County, State of South Carolina near Paris Station on the National Highway and lying between the right-of-way of the Southern Railway and the P & N Railway as shown on plat thereof prepared by W. A. Adams dated September 21, 1912 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the right-of-way of the P & N Railway and running along said right-of-way S. 46 1/2 W. 7.38 chains to an iron pin in Paris Mountain Road; thence with said road S. 23 7/8 E. 2.98 to an iron pin on right-of-way of the Southern Railway; thence along said right-of-way 7.71 to an iron pin; thence N. 32 W. 4.30 to the beginning corner and containing 2 1/4 acres, more or less.
